FOURTEENTH AMENDMENT TO AGREEMENT FOR ATTORNEY SERVICES BETWEEN THE CITY OF SAN JOSE AND HANSON BRIDGETT LLP

This FOURTEENTH AMENDMENT is entered into this <u>3rd</u> day of <u>November</u>, 2022, by the CITY OF SAN JOSE ("CITY"), a municipal corporation, and HANSON BRIDGETT LLP, a California limited liability partnership ("ATTORNEY").

RECITALS

WHEREAS, on May 21, 2012, CITY and ATTORNEY entered into an agreement entitled "Agreement for Attorney Services Between the City of San José and Hanson Bridgett, LLP" for legal services related to CITY's retirement plans ("AGREEMENT"); and

WHEREAS, between October 2, 2012 and July 29, 2022, CITY and ATTORNEY entered into amendments and continuation agreements to extend the term through June 30, 2023, expand the scope of services, revise the list of ATTORNEY staff and rates of compensation, make a clerical correction to the conflict of interest reporting requirements, and increase the amount of total compensation allowed to \$719,000; and

WHEREAS, CITY and ATTORNEY desire to further amend the amended and continued AGREEMENT to revise the list of personnel and hourly rates, with no increase in the amount of total compensation allowed;

NOW, THEREFORE, the parties agree to further amend the amended and continued AGREEMENT as follows:

SECTION 1. SEVENTH REVISED EXHIBIT C, "COMPENSATION" is amended to read as shown in EIGHTH REVISED EXHIBIT C, attached and incorporated into this Fourteenth Amendment.

SECTION 2. All of the terms and conditions of the amended and continued AGREEMENT not specifically modified by this Fourteenth Amendment shall remain in full force and effect.

SECTION 3. Unless otherwise prohibited by law or CITY policy, the parties agree that an electronic copy of a signed contract, or an electronically signed contract, has the same force and legal effect as a contract executed with an original ink signature. The term "electronic copy of a signed contract" refers to a writing as set forth in Evidence Code Section 1550. The term "electronically signed contract" means a contract that is executed by applying an electronic signature using technology approved by the CITY.
