### Revised Exhibit A: Scope of Basic Services

This revised Exhibit A is an attachment to the  First  Second  Third amendment to Agreement.

The tasks set forth in the original Exhibit A, or in any previous amendment to the original Exhibit A, are amended as follows:

**Task No. 1, entitled “Workers’ Compensation Legal Services,” is amended to read as follows:**

**A. Services:**

1. Attorney will coordinate all legal services, including settlement recommendations, with the City Attorney or the City Attorney’s designee. Attorney acknowledges and agrees that in the event of conflict between direction given by City staff and the direction given by the City Attorney, the direction given by the City Attorney or the City Attorney’s designee shall control.
2. Attorney shall provide workers’ compensation legal services as set forth in this Exhibit A for each Master Claim Number specified below. These Master Claim Numbers are assigned by the City, and are the primary claim numbers for the workers’ compensation applicant (alternatively, the “applicant”) under which any and all related workers’ compensation claims for the same applicant may be tracked by City. “Related Claims” may be filed prior to or after the date of execution of this Agreement.

3. Attorney shall not provide legal services for master claims that are not specifically authorized in paragraph A.2 of this **Exhibit A**, this Agreement or a written amendment to this Agreement.

**B. Deliverable:**

Attorney will be responsible for handling the above workers’ compensation cases throughout the litigation process including appellate review, and coordinating workers’ compensation cases with interrelated issues of retirement, safety, and return to work. Specific duties with respect to the above claims may include, but are not limited to:

- a. providing claim direction to City staff;
- b. at the request of the City Attorney or City Attorney’s designee providing guidance on workers’ compensation practices and procedures;
- c. reviewing disputed medical treatment and indemnity cases;
- d. performing discovery;

- e. representing the CITY before the Workers' Compensation Appeals Board ("WCAB");
- f. supervising and coordinating fraud and injury investigations;
- g. coordinating cases with employment law and disability discrimination issues;
- h. handling communication with the WCAB and State units.

**C. Completion Time:** The Attorney must complete the services and deliverable for this task in accordance with whichever one of the following time is marked:

- On or before the following date: June 30, 2023.
