FOURTH AMENDMENT TO CITY OF SAN JOSE GRANT AGREEMENT

This FOURTH AMENDMENT TO CITY OF SAN JOSE GRANT AGREEMENT ("FOURTH AMENDMENT"), is made and entered into upon the date of execution by CITY, by and between the **CITY OF SAN JOSE**, a municipal corporation of the State of California ("CITY"), and **VEGGIELUTION**, a California nonprofit corporation ("GRANTEE"). For the purposes of this FOURTH AMENDMENT, CITY and GRANTEE are sometimes collectively referred to as "Parties."

RECITALS

WHEREAS, on March 8, 2021, CITY and GRANTEE entered into an Agreement entitled "CITY OF SAN JOSE GRANT AGREEMENT" ("Agreement") in the amount of \$86,662 to provide services for the Collective Impact and Unmet Needs Grant Program through March 31, 2021, for total compensation amount not to exceed \$86,662;

WHEREAS, on April 27, 2021, CITY and GRANTEE entered into a first amendment entitled "FIRST AMENDMENT TO CITY OF SAN JOSE GRANT AGREEMENT" to amend the AGREEMENT to extend the term through April 30, 2021, revise the scope of services, revise the maximum total compensation to \$115,549, revise the Budget Summary, and revise the Payments to Grantee and Reporting Schedule;

WHEREAS, on May 19, 2021, CITY and GRANTEE entered into a second amendment entitled "SECOND AMENDMENT TO CITY OF SAN JOSE GRANT AGREEMENT" to amend the AGREEMENT to extend the term through May 31, 2021, revise the scope of services, revise the maximum total compensation to \$132,159.50, revise the Budget Summary, and revise the Payments to Grantee and Reporting Schedule;

WHEREAS, on June 25, 2021, CITY and GRANTEE entered into a third amendment entitled "THIRD AMENDMENT TO CITY OF SAN JOSE GRANT AGREEMENT" to amend the AGREEMENT to extend the term through June 30, 2021, revise the scope of services, revise the maximum total compensation to \$148,770, revise the Budget Summary, and revise the Payments to Grantee and Reporting Schedule;

WHEREAS, pursuant to Section 23 of the AGREEMENT, CITY and GRANTEE desire to further amend the AGREEMENT to-extend the term, revise the scope of services, revise the maximum total compensation, revise the Budget Summary, and -revise the Payments to Grantee and Reporting Schedule;

NOW, THEREFORE, the Parties agree to amend the AGREEMENT as follows:

SECTION 1. Extension of Term: The term of the AGREEMENT under Section 4 is hereby continued and extended through July 31, 2021.

<u>SECTION 2.</u> Increase Funding: The Compensation Amount under Section 5 of the AGREEMENT is hereby increased by the amount of \$28,887 for a total Grant Award not to exceed \$177,657.

<u>SECTION 3.</u> Third Revised Exhibit A, "Scope of Services," is hereby replaced in its entirety with Fourth Revised Exhibit A attached hereto.

<u>SECTION 4.</u> Third Revised Exhibit C, "Budget Summary", is hereby replaced in its entirety with Fourth Revised Exhibit C, attached hereto.

<u>SECTION 5.</u> Third Revised Exhibit D, "Payments to GRANTEE and Reporting Schedule", is hereby replaced in its entirety with Fourth Revised Exhibit D, attached hereto.

<u>SECTION 6.</u> Second Revised Exhibit H, "Retroactive Services," is hereby replaced in its entirety with Third Revised Exhibit H attached hereto.

SECTION 7. <u>Reaffirmation</u>: In the event of an inconsistency between this FOURTH AMENDMENT and the AGREEMENT, the terms and conditions of this FOURTH AMENDMENT shall govern and control the rights and obligations of the Parties. All other terms and conditions of the AGREEMENT not changed, amended, or modified by this FOURTH AMENDMENT shall remain in full force and effect.

SECTION 8. <u>Counterparts</u>: This FOURTH AMENDMENT may be executed in any number of counterparts and by each party in separate counterparts, each of which when so executed and delivered shall be deemed to be an original and all of which taken together shall constitute one and the same instrument.

SECTION 9. Use of electronic signatures: Unless otherwise prohibited by law or CITY policy, the parties agree that an electronic copy of a signed contract, or an electronically signed contract, has the same force and legal effect as a contract executed with an original ink signature. The term "electronic copy of a signed contract" refers to a writing as set forth in Evidence Code Section 1550. The term "electronically signed contract" means a contract that is executed by applying an electronic signature using technology approved by the CITY.

FOURTH REVISED EXHIBIT A SCOPE OF SERVICES

GRANTEE will provide the services as described in this EXHIBIT A.

In the event GRANTEE desires to modify the Scope of Services, GRANTEE shall apply to CITY in writing setting forth the requested modifications. CITY shall have the authority to approve the following categories of modifications, by letter signed by the CITY, without the necessity of a formal written amendment to this AGREEMENT.

- 1. Modifications to the times and dates of Scope of Services which do not affect the total units of services to be provided; or
- 2. Modifications to the location of services provided so long as the proposed locations serve the same Target Population and is consistent with the Grant Allocation Plan

A. <u>Period of Service</u>

The Grant Services will commence on December 31, 2020 and continue through July 31, 2021.

B. Description of Services

General Description and Purpose of Services: GRANTEE will distribute two hundred (200) fresh produce boxes, cleaning and hygiene items, dry/pantry food, to two hundred (200) families once a week within San José from December 31, 2020 to March 31, 2021.

GRANTEE will distribute two hundred and twenty-five (225) fresh produce boxes, cleaning and hygiene items, dry/pantry food, to two hundred and twenty-five (225) families once a week within San José from April 1, 2021 through April 30, 2021.

GRANTEE will distribute one hundred and thirty (130) fresh produce boxes, cleaning and hygiene items, dry/pantry food, to one hundred and thirty (130) families once a week within San José from May 1, 2021 through June 30, 2021.

GRANTEE will distribute one hundred and eighty (180) fresh produce boxes, cleaning and hygiene items, dry/pantry food, to one hundred and eighty (180) families once a week within San José from July 1, 2021 through July 31, 2021.

If GRANTEE receives Collective Impact Grant funds or other City of San José funds, the following services shall enhance, rather than supplant existing services. GRANTEE, to the extent possible, will acknowledge the CITY by using City of San José provided logos online or any other printed materials where sponsor logos are displayed.

THIRD REVISED EXHIBIT H <u>RETROACTIVE SERVICES</u>

The term of this FOURTH AMENDMENT shall be retroactive from December 31, 2020 and shall continue through July 31,2021. It is understood and agreed that GRANTEE has commenced work and incurred costs prior to execution of this FOURTH AMENDMENT in anticipation of its execution.

CITY agrees to reimburse GRANTEE for those costs in accordance with the terms of the amended AGREEMENT. However, in no event shall GRANTEE be reimbursed for costs incurred prior to December 31, 2020.
