WHEREAS, all rezoning proceedings required under the provisions of Chapter 20.120 of Title 20 of the San José Municipal Code have been duly had and taken with respect to the real property hereinafter described; and

WHEREAS, pursuant to Section 15168(c)(2) of the CEQA Guidelines, the City of San

José has determined the proposed rezoning is pursuant to, in furtherance of and within

the scope of the previously approved program evaluated in the Final Program

Environmental Impact Report for the Envision San José 2040 General Plan (the "FEIR"),

for which findings were adopted by City Council through its Resolution No. 76041 on

November 1, 2011 and Supplemental Environmental Impact Report (the "SEIR"), through

Resolution No. 77617, adopted by City Council on December 15, 2015, and Addenda

thereto, and does not involve new significant effects beyond those analyzed in the FEIR

and SEIR; and

WHEREAS, the City Council of the City of San José is the decision-making body for the

proposed subject rezoning to the CIC Combined Industrial/Commercial Zoning District, A

Agriculture Zoning District, OS Open Space Zoning District, PQP Public/Quasi-Public

Zoning District, and IP Industrial Park Zoning District; and

WHEREAS, this Council of the City of San José has considered and approves the

information contained in the FEIR and related City Council Resolution No. 76041, and in

the SEIR and related City Council Resolution No. 77617, and Addenda thereto; and

WHEREAS, the proposed rezoning is consistent with the designation of the affected sites

in the applicable General Plan; and

WHEREAS, Senate Bill 330 (2019) requires that rezoning actions by local agencies result

in no net loss of residential capacity, which residential capacity can be pooled and

accumulated by the City of San José in accordance with Senate Bill 940 (2020), where

even though the proposed rezoning (File No. C21-021) reduces the intensity of residential

uses and residential capacity by 1,843 residential units, the City currently has 16,851

residential units that were previously rezoned to increase residential capacity (File Nos.

PDC19-039, C20-002, C20-014, C21-003, C21-013, C21-015, and C21-016) such that

there is no net loss of residential capacity in San José resulting from the present rezoning

action; and, therefore, there remains a surplus of 15,008 residential units available (16,851-

1,843 = 15,008 units), satisfying the no net loss of residential capacity requirements of

Senate Bill 330 and Senate Bill 940.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF SAN JOSE:

SECTION 1. The recitals above are incorporated herein.

SECTION 2. All that real property hereinafter described in this section, hereinafter referred

to as "subject property," is hereby rezoned to the to the A Agriculture, OS Open Space,

CIC Combined Industrial/ Commercial, PQP Public/Quasi Public, and IP Industrial Park

zoning districts.

The subject property referred to in this section is all that real property situated in the County

of Santa Clara, State of California, depicted in Exhibit "A" attached hereto and incorporated

herein by this reference.

SECTION 3. The district map of the City is hereby amended accordingly.

SECTION 4. Any land development approval that is the subject of City File No. C21-021

is subject to the operation of Part 2.75 of Chapter 15.12 of Title 15 of the San José Municipal

Code. The issuance of a building permit to implement such land development approval

may be suspended, conditioned or denied where the City Manager has determined that

such action is necessary to remain within the aggregate operational capacity of the sanitary

sewer system available to the City of San José or to meet the discharge standards of the

sanitary sewer system imposed by the California Regional Water Quality Control Board for

the San Francisco Bay Region.
